# Junior Warden's Report

It's been a busy year for the three church gardens. The Cross Garden was barren and needed a new look. I designed a stone labyrinth around the cross to give the garden some character. I and volunteers planted shade-loving perennials between the stones. The Memorial Garden Ladies have done a wonderful job maintaining the garden. The side garden is flourishing and needed only maintenance and some new perennials.

I felt the Memorial Garden needed some updating. It's been thirty plus years since it was originally planted. Some bushes are very skeletal and need to be removed and the garden needs more color. I'd like to block the view of the neighbor's backyards so that when a loved one sits on the garden's bench, they see a wall of green and not concrete and garages. I'm contacting area landscapers and asking them to submit an updated plan for the garden.

In the past, we have had problems getting the watering system for the Memorial Garden to function. WE have contracted with Bob Richardson, a local watering system specialist, to maintain the system and make any needed repairs.

In and ongoing effort to stem the water flow during heavy downpours away from our neighbors, I bought twenty bales of straw (2x more than lat year) and laid them where the largest amount of water runs downhill. So far it's been effective.

Many outside structures ere in in need of power washing. Pat Nichols did a super job washing our sidewalks, parking lot medians, the picnic table, bird houses and posts, and the cross in the Cross Garden.

Our front lawn hasn't been maintained for many years. This fall, Randy Chapel aerated, seeded and fertilized the front lawn. Also thanks to Robert Ellis for finding and donating the aerator. We're also gaining a tiller, courtesy of Gail Crowe which will save us the cost of renting one.

Lastly, I'd like to thank all the volunteers who came out for the Saturday workdays during the year. I truly appreciate the help. Our gardens would not look as beautiful as they do if not for all their efforts.

# **Deacon's Report**

As I pause to consider St. Clement's over the past year, I guess what stands out for me the most is that it finally feels like a sense of normalcy has returned. After quite a long period of unfamiliar change, with years of canceled services and special safety measures we are beginning to settle back into our more familiar worship and ministry practice. Average Sunday attendance has increased and we have added several new names to our rolls, and I am grateful.

This year we continued to support our surrounding community with our time and material resources as we brought in our food donations for Storehouse for Jesus, Clemmons Food Pantry, and snacks for Morgan Elementary. We provided a delicious meal of meatloaf and mash potatoes to the woman at the St. Timothy's shelter, and many in the congregation accepted the call to become mentors for local area school children. I even recruited one member to join me at Crisis Control Ministries each week as a client services interviewer.

Personally, over the past year I have continued to serve weekly at Crisis Control Ministries in Winston-Salem manning the front desk, and providing assistance with poverty simulations in various locations as the need arises. I continue to serve as a member of the Bishop's Committee on Prison Ministry for the diocese, and am easing back into service with the Forsyth Jail and Prison Ministry as more opportunities present themselves. I spent my Wednesday evenings in 2022/23 as a mentor for the area Education for Ministry (EfM) group that met at St. Anne's Episcopal Church from September through May and enjoyed some challenging and enriching conversations.

I continue to enjoy serving St. Clement's liturgically, and being a part of our rich worship tradition is a privilege. I am encouraged by the number of new lay ministers that have felt the call to serve the parish as chalicists, lectors, and Acolytes (Go Booths; you rock!). And finally, I would like to again thank the congregation of St. Clement's for allowing me to take the summer off this past year to rest, read, and re-center. After many years of service to the church I am very grateful to have had this break. So, as we head down the home stretch this year with Advent 1 only four Sunday's away I look forward to seeing what new thing God will do at St. Clement's in 2024.

# Income and expenditures: General Operational Fund

Income is up and tracking to meet budget. Plate offerings are at nearly 93% of budget and unpledged donations are 221% of what we budgeted. Actual pledges are at 82%, which means over all, folks are staying current or ahead on getting their pledges in and we thank you for that!

# **Restricted Funds**

Our current balance is \$224,148.89. These funds are designated for specific uses (for example, the Memorial Garden or Building Repairs) and can typically be used only for those purposes.

## Common Trust

The Common Trust Fund, restricted for future building, totaled \$411,060.77 as of 9/30/23. This is up \$49,974.81 compared to this time last year when it was valued at \$361,085.96.

#### Vanco

The Vanco online system is a convenient tool, and its use continues to increase among donors. Once logged in, you can set up recurring donations or make one-time donations on a date of your choosing. Just a reminder, St. Clement's does not have access to any banking data, you can save yours safely and confidentially in your private profile. All donations are reported directly to R.L. Satterfield, our CPA firm, for record keeping. The fee that Vanco charges for processing donations is charged to the church, not to you, unless you choose to help offset those fees. We're charged 2.75% for credit card transactions and 1% for bank drafts.
